We normally charge on an hourly basis for work undertaken for our clients, at the rates set out below. Such work includes meetings, telephone calls, noting matters discussed, reading documents and correspondence, drafting correspondence and documents, considering approach and strategy etc.

We are able to offer fixed fees for certain pieces of work we undertake for our clients; and we will confirm if we are able to do so and will provide transparency on such fixed fees.
